..... **Career Opportunities**

College of Hair Design prepares graduates of its Esthetics program for licensing and careers in the Esthetics industry. These careers include entry level positions or ownership in the industry.

The Nebraska Department of Health and Human Services (DHHS) is the licensing approval agency.

August 5, 2025 Addition to Esthetics Program’s Student Dress and Image Code

Eye lash extensions are not allowed in the Esthetics Program. If eye lashes have not been removed by week 2 of the program, the student may be sent home which will affect the student’s attendance percentage.

Acrylic nails cannot be worn while in the Esthetics Program.

August 1, 2025.....Esthetics Kit Fee Change
New esthetics kit fee (Tools & Books) \$3350.

July 1, 2025.....Extension of Catalog Publication Period
Effective July 1, 2025, the catalog covers the period ending December 31, 2025.

July 1, 2025..... Removal of Overtime Charges
Effective July 1, 2025, students enrolling in programs beginning on or after August 1, 2025, will not incur overtime charges.

March 31, 2025 Esthetics Evening Program

The College of Hair Design has launched an evening Esthetics program, with the first class starting on May 12, 2025. Tentative future start dates include August 4 and October 27, 2025.

While the current Catalog remains in effect, the following additions apply to the evening Esthetics program:

- Classes are held Monday through Friday, from 5:00 p.m. to 10:00 p.m., totaling 25 hours per week.
- The duration of the program is 24 weeks or 6 months.
- The Maximum Time Frame for program completion is 30 weeks or 726 hours.

March 14, 2025 Removal of Application Fee

College of Hair Design no longer charges an application fee of \$50.

December 18, 2024

Students who clock in late from lunch will not have adjustments made to their time, resulting in lost hours or minutes.

Students will receive three courtesy calls, notifying them of waiting guests. After three courtesy calls and no communication with the front desk from the student, the student will be sent home for the rest of the day, resulting in lost hours or minutes.

December 6, 2024 **Notification of Change in Graduation Date**

If a student does not complete the program by the graduation date outlined in the enrollment contract, a fee will be incurred which is referred to as the "overtime charge." This fee is associated with extending the time in the program. To address this, the Financial Aid Department will arrange a meeting with the student to review the details of the additional charge and confirm the updated graduation date.
